## **Rules for Membership & Members of Greater Noida Sharadia Sanskritik Samiti**

### **Eligibility for membership :**

The membership of the Society shall be open to all those who know or are interested in the Bengali language and Bengali culture provided that:

- (a) He/She is not less than 18 yrs of age; and
- (b) He/She has a bonafide citizen of India; and
- (c) He/She has sympathy with the objects of the Society; and.
- (d) He/She agrees to abide by the rules and regulations of the Society (as amended from time to time).

Persons desirous to be a member has to apply in a prescribed application form along with two stamp sized photograph and will be admitted as a member subject to the approval of the Executive Committee at its next meeting. Application may be rejected by the Executive Committee and will reserve the right of not stating the reasons of refusal for admission.

### **Membership Subscription :**

1. **Life Member** : A Life Member will pay Rs.8000/- (Rupees Eight Thousand only) as one time subscription. Besides, i) Rs.2000/=(Rupees two thousand only) is collected towards ONE TIME donation to land fund and ii) a Monthly maintenance charges of Rs.100/- per Bengali family which may be paid in single installment of Rs.1000/-(Rupees one thousand only) annually in advance.

2. Member has to deposit his Annual Subscription in Cash or by Bank Draft to the Samiti's office in the month of April and to keep the Receipt slip given to him by Samiti with him.

The Executive Committee on the approval of the General Body may time to time revise the subscription for membership. Neither the membership subscription nor any part thereof shall be refundable to any person for any reason thereof. Subscription will only be refunded if any application for admission as a member is rejected by the Executive Committee.

### **Responsibilities of Members :**

To help Executive Committee or Sub-committee is doing Samiti's work in order to achieve the aims and objectives of Samiti as and when he/she is requested by Executive Members due to high work-load.

### **Cessation of Membership :**

In the event of death, insanity, resignation addressed to General Secretary and approved by the Executive Committee. If the membership subscription is not paid in the first quarter of the financial year, the member shall thereafter cease to enjoy the privileges of membership until the subscription is paid. The Executive Committee may, by resolution, suspend or remove any member from the membership, if the conduct of such member has in the opinion of the Executive Committee, been either contrary to objects of the Samiti or derogatory to the honour and dignity of the Samiti, by a resolution adopted by not more than two-third of the number of the members of the Executive Committee. Member wishing to withdraw from the Samiti will be liable to pay all the sum of money due from him to the Samiti at the time of his withdrawal.

### **Right to Vote and Election :**

1. A member shall be allowed to vote in the General Body Meeting provided he/she has paid the yearly subscription up-to-date at least one month before the election of the Executive Committee.

2. A member shall be eligible to be elected as a member of the Executive Committee when he is a member of the Samiti for at least one year preceding the day of the Election the Executive for the second financial year and consecutive elections thereafter. Proxy voting is not allowed

3. A member shall be eligible to be elected as a General Secretary when he or she was a Office Bearer in the Executive Committee for at least one year before the day of election of the Executive Committee for the Third Financial Year and consecutive elections thereafter.

Apart from the above, all members and their membership will be subject to the Memorandum of Association of the Greater Noida Sharadia Sanskritik Samiti and the rules and regulations formed herein under, as may be amended from time to time.
