Essential Notes:

- 1. Office Bearer positions of GNSSS are (a) Vice President 1, (b) Vice President 2, (c) General Secretary, (d) Joint General Secretary, (e) Treasurer, (f) Assistant Treasurer and (g) Cultural Secretary. The President holds the status of an office bearer but is not elected through a general vote. Instead, the position is filled by unanimous agreement among the elected members of the Executive Committee. If consensus cannot be reached, the President will be chosen by a simple majority vote within the Committee.
- 2. This form must be submitted in person to the Election Committee office located at the Kalibari compound. Upon submission, an acknowledgment will be provided. The Committee will be available daily from **Wednesday, July 9, 2025, to Friday, July 18, 2025, between 5:00 PM and 8:00 PM**.
- 3. Nominees are advised to keep a photocopy of the form for their record.

INSTRUCTIONS FOR FILING UP THE NOMINATION FORM

- 1. Fill in the application form in block letters.
- 2. Paste 1 passport sized photograph on the form & email a digital copy of the same photo for ballot paper printing, to electioncommitteegnsss@gmail.com.
- 3. In the 'Name & Aadhar Number' column, the box with the 'A' is for the Aadhar number of the proposer & seconder respectively.
- 4. In the 'Residential Address & Mobile Number' column, the box with the 'M' is for the mobile number of the proposer & seconder respectively.
- 5. Attach self-attested copies of all the following documents with the filled nomination form:
 - a. Aadhar Card (If Aadhar is of the current address, then document 'c' not required)
 - b. PAN Card
 - c. One address proof (Electricity Bill | Broadband Bill | Rent Agreement | Registry paper (first page)
 - d. Completed and signed the "Declaration and pledge" letter
- 6. Life members who joined the Samiti on or before March 31, 2024 and have paid the annual maintenance fee for the financial year 2024–25 are eligible to contest elections. However, candidates aspiring to contest for the position of General Secretary must also have served as an office bearer of the GNSSS Executive Committee for a minimum of one year prior to this election.
- 7. Each nominee can submit only one nomination form.
- 8. Details in the nomination form shall be checked & if found incorrect, the EC reserves the right to reject the nomination form.
- 9. The authenticity of the attachments shall be checked by the EC & if found incorrect, the EC reserves the right to reject the nomination form.
- 10. Incomplete submissions, meaning submissions that fall short of any of required information or attachments shall be rejected by the EC.
- 11. Forms cannot be submitted with the express understanding that the attachments shall follow later.
- 12. The 'Proposer' & 'Seconder' must be GNSSS life members only.
- 13. One life member can 'Propose' or 'Second' only one candidate. The same life member cannot 'Propose' one & 'Second' another candidate. In such a situation the nominee whose candidature is received/opened second shall be inoperative.
- 14. Candidates who are contesting the elections cannot 'Propose' or 'Second' another candidate. If so done, the Proposer's / Seconder's candidature for nomination shall be inoperative.
- 15. In all disputes regarding the above-mentioned rules the EC is the final authority & its decision shall be final & binding.
